

Information for Solicitors/Executors

If you're acting as an executor or solicitor, you should know a gift in a Will is for us if it contains some or all of the following information:

- Our registered charity number (1052813) stated in the Will. Our Registered Charity Number is unique to us as a charity, and will identify us as the benefactor immediately.
- Our name, or a variation of our name (for example 'the LHCH Charity, Liverpool Heart and Chest Hospital, Heart and Chest Hospital, Broadgreen Heart and Chest, etc) appears in the Will.
- Our address appears in the Will -
Liverpool Heart and Chest Hospital Charity,
Thomas Drive, Liverpool, L14 3PE

You may also know a gift is for us if there is any of the following:

- A history of lifetime support for LHCH Charity by the person who made the Will
- Any clues in the notes taken by a Will draftsman when the Will was made, that indicate we could be the benefactor.

Please use reference –“Legacies – [Surname of Deceased]” so as to assist us in identifying the payment when it is made.

When you make a legacy payment, we'd be really grateful if you could send an email to enquiries@lhchcharity.org.uk and provide the following details:

1. The full name and title of the deceased
2. Their last address – this will also allow us to prevent any future mailings, as we know this can be distressing at a difficult time
3. The date of death
4. The Executor's name and contact details
5. A copy of the Will
6. Any information about the reason for the legacy.

Your details as executor will not be added to any mailing lists as a result of contacting us about a legacy.

Gifts in Wills and Tax Exemption

As a registered charity, we're exempt from inheritance tax, capital gains tax and some aspects of income tax. These exemptions apply to legacy gifts and estate administration, and can increase the value of a gift at no cost to any other beneficiary.



However, these exemptions have limitations and it can be complicated to work out. You might need to get specialist advice. To avoid the estate paying more tax than necessary you may find HMRC's website and helpline (0845 302 0900) useful.
